## ISSUES OF INTEREST



### AIR POLLUTION and AIR QUALITY

Our “carbon footprint” is a fancy name for measuring how much carbon dioxide you produce. Whether or not you believe carbon dioxide is the cause of global warming, it is harmful to the environment and when you reduce your carbon footprint you not only help the environment, reduce air pollution and save money. Scientists have shown that air pollution from cars, factories and power plants is a major cause of asthma attacks. And more than 159 million Americans -- over half the nation's population -- live in areas with bad air. A research study published in 2002 estimated that 30 percent of childhood asthma is due to environmental exposures, costing the nation \$2 billion per year. Studies also suggest that air pollution may contribute to the development of asthma in previously healthy people. Ground level ozone, sulfur dioxide, particulate matter and nitrogen oxides are produced by car emissions and coal generated power plants. Energy conservation – merely replacing lights with CFL or LED can reduce power consumption and reduce need for additional coal generated power plants. Simple steps such as when you purchase a new car look at the gas mileage; consider a hybrid, alternative fuels or more efficient vehicles. Ride the metro, bus, bicycle or walk for short trips. Combine automobile trips and do not ride alone: car pool to meetings at the League Office, to church etc can help to reduce your energy consumption and help to save money and improve the air we breathe.

When you drive - drive wisely:

- 1. Idling:** You'll save gas and reduce emissions by turning the engine off and restarting it when you would otherwise idle for two minutes or more.
- 2. Stop-and-go driving:** Avoid travel during congested, peak rush-hour traffic. Try to smooth your driving by accelerating and decelerating gradually, anticipating stops and starts for traffic lights, changing traffic speeds and so on.
- 3. Park your car in shaded areas** whenever possible, besides keeping your car's interior more comfortable, you will lessen pollution and wasted fuel that results from gasoline evaporating from the engine and gas tank.
- 4. High engine loads:** Besides using your car's air conditioner, quick acceleration, high speeds, climbing grades, revving the engine and carrying or pulling extra weight all make the engine work harder. Leave earlier when making a trip to avoid the need to speed.
- 5. Reduce drag:** To save gas and cut emissions, don't carry unneeded items in your vehicle, and reduce drag by carrying cargo inside rather than on your roof racks.
- 6. Maintain Your Car and all gas engines (including lawn mower, boats etc)**

Indoor air pollution can also contribute to health problems. We will have more information in future articles as we approach our Unit Presentation in March.



# ELECTION 2010

## LWVUS President Visits STL



On October 22nd, National League President Elisabeth MacNamara paid a visit to St. Louis. On the last leg of her cross state visit, Elisabeth met with the Board for an enjoyable meal in St. Charles before moving on to the St. Charles Community College, where she moderated the Forum for the U.S. Representative 2<sup>nd</sup> District. She remarked that she is seeing the same issues across the country during the election. Unfriendly audiences and less than cooperative candidates or their representatives have often changed the tone of the forums. As a result of this, the national office is compiling a resource for leagues containing the preparations undertaken by leagues in anticipation of difficult crowds and the actual occurrences.

Kathleen Farrell and Linda McDaniel shared their experiences with Elisabeth while she was here. Those in attendance enjoyed meeting with Elisabeth and hope she will have occasion to visit again when she can speak to more of the members.

## LEAGUE HOSTS SOUTH AMERICAN OFFICIALS

On Election day the League office had a visit from four gentlemen from South America, Sebastian Bowen, Chile, Executive Director/Founder of Frecuencia Publica; Josue Puluc Perez, Guatemala Legal Representative and President, VIJOVEN; Jose Noe Cortes Moncada, Honduras, Executive Secretary, National Party of Honduras; Eric Garcia Hernandez, Panama, Coordinator of Plans and Projects, Ministry of Economics and Finance; and Juan Jose Portillo Rangel, Venezuela, Secretary, Economic Development, Government of Zulia State. They were visiting several states for a 21 day tour sponsored by the Department of States International Visitor Leadership Program, *Grassroots Democracy and Citizen Participation in the Political Process*. The visit in St. Louis was facilitated by the World Affairs Council. We met with them for about an hour and half through an interpreter. We talked about the suffragists and activity of the League today, voters guides, candidate forums, study, positions and advocacy. They asked great questions about how we got members, how we are funded, why it took so long for the 19<sup>th</sup> Amendment to be passed, why men would not vote for it. It was a great discussion, including their pointing out how many women today are involved in and head their governments. We ended with an expression of gratitude to the suffragist for leading the way for women not just in America.



## VOTERS GUIDES and PROP A EFFORT: a Perspective

I would like to say that I am very proud of the role of our League in informing voters about the November 2, 2010 election. The “Voters Guide” in collaboration with the Post-Dispatch under the leadership of Kathleen Farrell and Linda McDaniel and the Candidates Forums under the leadership of Pat Jones and Linda McDaniel were League Voter Service at its best.

I am equally proud of our League’s advocacy in opposition to Proposition A. Unfortunately, it did pass statewide which means that both the City of St. Louis and Kansas City are required to vote next April on whether they want to retain or eliminate the sales tax. Fortunately, the proposition failed in each city which indicates that voters there know that voting to eliminate the earnings tax would be devastating for their cities. But we cannot take anything for granted. The campaign to continue the earnings tax is starting now for the April election. You will be hearing about that in future “In League Reporters”

Quick review of our advocacy work on Prop A


- The League was very visible in the campaign and got lots of community recognition.
- The League board and the League units received briefings on the ballot issue so that members would be able to advocate knowledgeably.
- A League release was published in its entirety in the “St. Louis American”
- A three minute commentary was aired on KWMU with positive feedback from the public.
- An article appeared in every issue of our “In League Reporter” since the fall.
- I attended weekly meetings of the anti-Prop A Coalition called United for Missouri Priorities
- The League office distributed about 70 Vote No on Prop A yard signs.
- League distributed a stack of Vote No fliers.
- Eight League volunteers made about 300 calls at a telephone bank.
- Had an op-ed piece in the Post Dispatch disputing the proponents “Let the Voters Decide” CAMPAIGN.”
- Had a brief letter to the editor in the Post Dispatch 2 weeks before the election.
- Had long letter to the editor in the St. Louis Jewish Light the week before the election.
- Had a League sign on the platform and League member attendance at the St. Louis Metropolitan Congregation United Rally in Kiener Plaza
- One League member went door to door dropping off literature in her neighborhood.
- The League telephone service answered questions on Prop A
- A couple of League members worked the polls in opposition to Prop A
- In addition local Leagues throughout the state had their own anti-Prop A activities.

One of the positive outcomes of this campaign was the contacts we made with community members from other organization with whom we worked in coalition.

At the October Board meeting, the LWVSTL Board approved the recommendation of the Investment Committee to write a job description for the position of Part-time Development Professional. This individual would write grants for the organization and support the solicitation of other potential donors. It is estimated that this effort would require approximately \$10,000 per year. The Board also approved the position of Volunteer Coordinator. This would be a part-time position. Hopefully a league member will be interested in this. ## Thoughts on Questions from the Fall 2010 Candidate Forums

We've all heard the statement, "The only dumb question is the one not asked." I think it is safe to say that during the Fall 2010 Candidate Forums, there were very few questions not asked. Various League members have recently inquired about the type of questions submitted at the forums. I decided to ask some of our wonderful League volunteers who collected, sorted, and read the cards to share their thoughts about the questions.

"There were far too many personal questions." This quote from Agnes Garino, a card sorter at the St. Louis County Executive Candidate Forum, is an accurate summary of many of the questions at all six forums. In addition to the personal nature of the questions, Agnes thought that a "lot of questions were from each candidate's supporters, some pro for their candidate, some definitely an effort to put the opposition on the spot."

Kathleen Farrell moderated three of the six forums; she saw a lot of questions and had this observation: "There were many more questions this time around that were not true questions that attempted to get information. Rather they seemed to be set ups for stumping candidates, setting them up to say something that would hurt their credibility. On the other side, you could pick out the 'fan' questions- softballs to make a candidate look good." Kathleen said that some of the questions had "ideological assumptions in them which were very clearly announced."

Because of the large number of forum attendees, stacks and stacks of cards were distributed. Some people wrote long diatribes on the front and back of cards. Agnes stated that there were "many more questions than I anticipated." Card sorters were essential. The questions were grouped according to subjects such as jobs, the economy, health care, education, and immigration. Esther Clark, card collector at the



U.S. Representative 3rd District Forum in Arnold, said that the card sorters "working behind the scenes choosing which questions to use had their work cut out for them." Esther went on to say, "They did a good job of sorting out the good ones, combining and rephrasing some of the others that were very slanted and outright insulting."

The U.S. Representative 3rd District race presented a challenge for the League, not only because of the contentious nature of the race, but because the League was asked to sponsor and moderate two forums for the candidates. The first forum was held at Forest Park Community College and the second at the Arnold Rec. Center. I think League volunteers for both of these forums would agree that the near capacity crowds and large quantity of questions added to the challenge.

Mary Long, card sorter at both 3rd District Forums, had this to say about the questions, "A very large number of questions at both 3rd district forums were personal attacks from supporters of one candidate trying to embarrass the other candidates. The majority of people attending were not there to learn but were the organized supporters of one of the candidates. Huge numbers of questions at both forums had to be discarded as totally inappropriate. I think it is good that we did this but it was a disheartening first hand look at a not too attractive side of the public."

Dixie Buford, card collector at the 3rd District Forum at Forest Park Community College, had a more positive view of the questions: "I thought MOST of the questions were reasonable, thoughtful, and appropriate. The 'off-the-wall' questions were the minority. There were many duplicates which is understandable."

The tone of the questions and answers varied from one forum to the next. While the 3rd District Forums attracted some audience members who were disruptive and asked inappropriate questions, the behavior of the candidates and audience at the forum for the State Representative 94<sup>th</sup> District in Kirkwood was considered to be more dignified. Esther, who collected and sorted cards at the Kirkwood forum, stated that the “questions and answers were more thoughtful and informational.”

The St. Louis County Executive Candidate Forum was distinctive from the other forums because a panel of three political science professors asked the candidates follow-up questions. Agnes thought the panel “added another dimension that seemed effective, making sure issues that should be of general interest got addressed.”

Two of the three candidates running for the U.S. Representative 2nd District participated in a

forum at St. Charles Community College that was not as well attended as the other forums this fall. The absence of the incumbent was unfortunate, but a wide range of questions about the issues were covered at this very civil forum.

The League’s Candidate Forums are built around **questions about issues** written on cards. Unfortunately, the issues are often overshadowed by misrepresentation of facts, negativity, and personal attacks which are reflected in the questions. It is easy to become discouraged, and to think that the “dumb” questions far outweigh the legitimate questions, but that is precisely why it is so important for the League to continue its commitment to providing nonpartisan public forums to the community.





The show explores the unlikely love story between Oxford professor C. S. Lewis (author of The Narnia Chronicles) and American poet Joy Gresham. The story also deals with his struggle with personal pain and grief: Lewis preaches that one should endure suffering with patience, but finds that the simple answers he had preached no longer apply when Joy becomes afflicted with cancer and eventually dies.
