#### **AUG. 7th STATE PRIMARY ELECTION**

Missouri's state primary elections are held on the first Tuesday after the first Monday in August of even numbered years. Since Missouri has open primaries, every eligible registered voter may select the party ballot of their choice. However, primary voters may select only one party's ballot. Voters who do not wish to give a political party preference may request an issues only ballot, if one is available in that particular jurisdiction.

The filing period for the August 7, 2012 state primary election is from February 28 to March 27.

On Tuesday Jan. 17, the Missouri Supreme Court threw out redrawn state Senate districts and called for review of the new congressional district lines.

#### 2012 Initiative Petitions Approved for Circulation

Some 45 petitions have been certified by the Missouri secretary of state's office

Petitions cover subjects ranging from campaign finance, early voting, eminent domain, consumer loans, minimum wage, taxation, to tobacco/cigarette taxes. Petitions must meet signature requirements by the deadline to be put on the ballot. #### **Township Redistricting Information**

Per Missouri law, the Board of Elections redrew the St. Louis County Township boundaries into 28 compact and contiguous townships containing population as nearly equal in population to each other as is possible per the 2010 decennial census.
