## LEAGUE LAUNCHES IMPORTANT PROGRAM INITIATIVE

At the July board meeting, we decided that we should hold a public community meeting on an important issue. After much lively discussion of three good topics, "What should Government Do for its Citizens? What does it really mean to provide for the general welfare" received top endorsement. Given current debates over budgets, program cuts, and the government's role at the national, state and local level, a constructive conversation is needed. And who can facilitate such a discussion better than the League? We believe that early Spring 2012 is the ideal time for such a program. The 2012 presidential race will be underway, the Missouri Assembly will be beginning its work, and local elections will be held in April.

The board also considered two other options: programs that would provide information on the practical effects of the implementation of the Affordable Care Act and a program of civic education. We will ask the Health Care Committee and those who have expressed an interest in Civic Education to consider preparing proposals for consideration for the 2012-2013 program. We don't know what is hotter - the budget talks in Washington or this St. Louis summer! We do know that there has been plenty to keep us busy and we are looking forward to September's Kickoff to begin the year's activities.

We were pleased that Governor Jay Nixon vetoed the Voter I.D. bill last month. As he indicated in the press release announcing his veto, this bill would jeopardize over 230,000 Missouri registered voters who do not have a current Missouri driver's license. It would jeopardize seniors, people with disabilities, the working poor, students and African Americans who are twice as likely to lack such I.D. In addition, the cost of implementing the legislature's photo ID proposal would cost well over \$20 million, a price tag the people of Missouri cannot afford, particularly when there have NOT been reports that voter fraud has occurred. Thank you to all of you who responded to our call for emails, phone calls and letters. Apparently many leaguers across the state and particularly St. Louis made their position known. We know, however, that this issue is not going to go away. The Advancement Project, the coalition to which we belong, filed a lawsuit on July 6<sup>th</sup> (along with the Fair Elections Legal Network, the American Civil Liberties Union of Eastern Missouri, and the ACLU of Kansas and Western Missouri over the "deceptive and misleading" Voter ID Ballot Initiative. It was the first ever challenge to a Photo ID constitutional amendment filed on behalf of the elderly, people with disabilities, racial minorities, and students who face loss of voting rights. The lawsuit asks the court to block the initiative from appearing on the November 2012 ballot because it "deceives and misleads voters about what the amendment would and would not do and thus is neither true nor impartial, but instead likely to create prejudice in favor of the proposed measure." This issue strikes at the heart of what the League believes - that all should have access to open and free elections. We will keep you posted on further developments.

Save the dates for two important events – the 24<sup>th</sup> annual Equality Day Brunch on Saturday, **August 20, 2011**, featuring speaker Betty Dukes, lead Plaintiff in Supreme Court Case Dukes vs. Wal-Mart. We hope to have a good group from the League at the Equality Day Brunch to network with folks who share our interests and encourage them to become League members. Our annual kickoff on will be **Wednesday, September 14<sup>th</sup>**. The kickoff's featured speaker will be Dr. Kathleen Sullivan Brown from UMSL speaking on education, which is the subject of our national study. Now is the time to get involved with that study chaired by Marty Ott.

Finally, LWVUS President Elisabeth MacNamara will be visiting St. Louis near the end of August. We have not received her travel itinerary yet, but will hold an event where all members will get the opportunity to visit with her and share their thoughts about the recent Clean Air Act amendment vote cast by Senator Clare McCaskill and other issues. As soon as we get the dates of her visit nailed down, you will be hearing from us.

Thank you for all the volunteers who keep coming in during these hot months to help with our work. Let's all identify a friend or two to recruit as new League members and bring them to the September kickoff. Once they meet us, how can they resist?

## REPORT FROM THE TREASURER 2011–2012

### **LWV St. Louis Treasurer's Report**

The St. Louis League operates on a fiscal year of July 1 to June 30. Our income for the year just ended exceeded our expenses without drawing from reserves.

Our income totaled \$40,565 and expenses were \$37,600. Income consisted of members' dues of \$17,970 and member contributions in addition to dues of \$6,779. Other fundraising totaled \$12,501. Member meeting and product revenue was \$3,178. In addition to the above revenue there was other income of \$137.

The League's major expense was our share of operating the office and salaries for the two staff people we employ. These expenses totaled \$22,978. Fund raising costs were \$1,212. Expenses for June 2010 National convention delegates reimbursed in the current fiscal year were \$2,252. Cost of member meetings was \$2,522. National per member payment (pmp) which is based on number of members was \$4,277, state pmp was \$4,320. Miscellaneous costs were \$39.

More detailed financial information is available by contacting the treasurer, Cindy Mitchell through the office.

### **League of Women Voters Information Service Treasurer's Report**

LWVIS also operates on a 7/1 – 6/30 fiscal year. The year ending June 30, 2011 was a very successful year in providing voter services to the St. Louis community. However, financially our current expenses exceeded our income by a substantial amount.

Contributions from individuals and tributes totaled \$5,284. Other fundraising raised \$7,835. Our investment income was \$9,870.

Our expenses included the organization's share of the office operating costs of \$34,990. Other expenses included ½ of our National League's Per Member Payment of \$4,277, printing of our Register and Vote informational pamphlet \$727, fund raising expenses of \$908, the Civility workshop cost of \$1,997 (which was covered by participants' fees and monies in the Missouri League's Ed Fund) and miscellaneous expenses. Total expenses were \$43,500.

**MSD RATE INCREASE**

**METROPOLITAN ST. LOUIS SEWER DISTRICT RATE PROPOSAL**

On May 10, the Metropolitan St. Louis Sewer District submitted a Rate Change Notice to the Rate Commission of the District. The Rate Commission was established as part of amendments to the MSD Charter which were passed in an election in November, 2000. The Commission is made up of fifteen organizations reflecting a wide variety of rate payers in the District. Each organization designates a member to represent the organization on the Commission. The League is a Commission member. The responsibility of the Commission is to review any proposed changes to wastewater and storm water rates or rate structure. The Charter requires that any proposed rate change or any portion of the change:

1. Is consistent with constitutional, statutory or common law as amended from time to time;
2. Enhances the District's ability to provide adequate sewer and drainage systems and facilities or related services;
3. Is consistent with and not

in violation of any covenant or provision relating to any outstanding bonds or indebtedness of the District;

4. Does not impair the ability of the District to comply with applicable Federal or State laws or regulations as amended from time to time; Imposes a fair and reasonable burden on all classes of rate-payers.

The Rate Change Proposal covers fiscal years 2013 through 2016 (July 1, 2012 through June 30, 2016) and affects only wastewater rates. The projected monthly rates for the average single-family customer are \$28.73 in 2012, \$32.37 in 2013, \$36.71 in 2014; \$41.56 in 2015, and \$47.05 in 2016. The District is requesting these rates to meet regulatory requirements and provide funds for the costs of issuing and paying interest on bonds. Other rate change drivers include the loss of customer base, declining water usage and the general state of the economy.


In addition to the rate changes cited above, the proposal provides for a bond issue of \$945 million to be put to the voters in April, 2012. The bond issue would be used to finance the District's capital improve-

ment program. An alternative structure is presented using no additional bonds but financing the capital improvements on a cash basis. This would result in an initial increase in rates in fiscal 2013 to \$73.35 and to \$74.40 in 2016.


An important component of the rate review process is the public hearing. Six hearings will be held throughout the District at various locations and times. The hearings will include a presentation about the proposed rates and an opportunity for the public to provide input to the Commission.

## FEDERAL ROLE IN EDUCATION STUDY

*America's future will be determined by the home and the school. The child becomes largely what it is taught, hence we must watch what we teach it, and how we live before it.*

*Jane Addams*

The delegates at Convention 2010 approved a national study, the “Federal Role in Public Education”. The Education Study is broad and includes the following areas: historical perspective, funding and equity issues, and the Common Core Standards. This very important study will be presented at the October and November Unit meetings, and your participation is strongly encouraged. Education has been at the forefront of many discussions, locally, and nationally. Our members will have the opportunity to ask questions, voice their opinion and contribute ideas during the Consensus process. Consensus is the sense of the group on each question. Other local Leagues in the United States will be meeting and answering the same questions.

Since the 1960's the League has been building support for equal access to education. Positions include support for early childhood education, federal programs designed to meet the needs of the poor and minorities and to give women equal access to education opportunities and opposition to tax credits for families of children who attend private schools. The previous articles in the In League Reporter presented information about the history of the federal role in public education, and the equity and funding issues. This is third in a series to inform our members about the topics under consideration.

### Impact upon Early Childhood Education

Origins of the Early Childhood program began with Head Start in 1965, a part of the Elementary and Secondary Education Act (ESEA). This program was funded by the United States Dept. of Health and Human Services. Its purpose was to assist low-income families and children through some at-risk areas. Title 1 (ESEA) also has programs for early education. The money varies from state to state. Reauthorization of the Elementary and Secondary Education Act (ESEA) in 2001, called No Child Left Behind (NCLB), was signed into law. It promotes use of Title 1, Part A, funds pre-schools, emphasizing the importance of preparing children for entering school with language development and cognitive and early readiness skills. What is the role of the Federal Government in early childhood education? Should it extend to all children?

### Education of Children with Special Needs

Traditionally, all federal money has been aimed at special groups. These may be minorities – those with disabilities, living in poverty, non-English language learners, or others with identifying characteristics. Many of these


are growing nationwide, and funding does not always keep up with the growth. Should funding be targeted for special groups, block granted or blended into the general revenue?

These are a few of the questions we will be asking for this most important study, “The Federal Role in Public Education”.

### In Memory of Anita Koester

Anita Koester passed away July 10 from complications of ALS. She and I were friends for a number of years, drawn together because of common interests: the League of Women Voters, the United Nations, and Citizens for Global Solutions. She and I were co-chairs of the League's International Relations Committee for several years until she had to take a leave to care for her first husband. In 2004 I was involved in organizing a symposium on CEDAW and she was a vice president for the UN association; at that meeting she gave an impassioned speech pleading for the ratification of that UN Convention on women's rights. Perhaps the issue/document one thinks about when Anita's name comes up is the Universal Declaration of Human Rights; her knowledge of that document was phenomenal. Not only could she recite it from beginning to end or from any point in between but she also knew what each article meant and how the US stood on each one. Some might have called her zealous; others would have said she was just supremely dedicated to human rights for all mankind and fully believed those rights should be acknowledged by all in our world community. She brought the issue of human rights into most discussions we had in the IR Committee whether we were studying issues regarding trade, immigration, or a particular country. She wrote and self-published a tract on that subject: Justice, Human Rights and a Single Global Civilization. She will be missed by many – family and friends alike.

### From the Executive Director's Desk - Anna Mennerick

*What is the Joint Office?* - - - Many newcomers and even seasoned League members have questions about this unique organizational relationship. The Joint Office, for starters, is a place and an entity. The Joint Office "place" is open from 9:30-3:30, Monday-Friday. The Joint Office "entity" is an affiliation of the LWV Missouri, LWV Missouri Ed Fund, LWV St. Louis and LWV Information Service.

The Joint Office and the Joint Office Staff serve all four organizations as stipulated by the Joint Office Steering Committee, with representation from each organization's board officers. The Joint Office "entity" hires and pays staff, schedules resources and maintains the equipment and supplies in the Joint Office "place." Joint Office costs appear in each organizational budget as adopted by its members or board. The Joint Office receives income in the form of monthly payments from each of the four organizations for their portions of shared costs in addition to specific organizational expenses.

Remarkably, this arrangement works. Occasionally, every organization has something going on at the same time which does increase the excitement. This practical collaboration is a great way for the state and local Leagues to pool resources and share expertise.
