# ANNUAL MEETING APRIL 30TH

The Annual Report, to be distributed to members at the Annual Meeting contains specific reports, minutes and budgets to be discussed

Important note from Linda McDaniel:

My apologies to the membership. I failed to get the report for program planning recommendation in the April "In League Reporter". This will be considered at the Annual Meeting on April 30th.

## LOCAL PROGRAM PLANNING

The report and recommendation of the board is as follows. These recommendations are a result of the program planning discussion held in units.

### RECOMMENDED:

1. Retention of all local positions with the exception the Kirkwood and University City positions, these should be dropped.
2. An editorial change of adding the words "St. Louis City County" in two sections under government:  
Support of effective, efficient, responsive and responsible City of St. Louis, St. Louis City County and St. Louis County governments.  
Support for long range fiscal planning for municipalities, St. Louis City County and St. Louis County.
3. A study to re-examine the issues of combining the City of St. Louis and St. Louis County.

### DROP:

1. Kirkwood City Charter: Support of the Chief Administrator Officer form of government with continued interest in the Kirkwood City Charter.
2. Kirkwood Public Library: Support of a Public Library that meets the needs of the residents. Support of adequate financing, long range planning and a library board which is representative of all segments of the community.
3. University City Government: Support of the council-manager form of government for the City of University City, with continued interest in the city charter.

### NOT RECOMMENDED:

1. A study of the financial effect on the funding of education with the transfer of money from a school district to vouchers and charter schools.
2. Revision of Education position: add "education excellence".
3. Support a sound program for financing schools and school programs of educational excellence, including civics curriculum, for students to develop their full potential.

# ISSUES OF CONCERN



## Indoor Air Quality, Should We Be Concerned?

We have all been told that our homes need to breathe. I am not sure we ever really understood why or how much and in addition to this, we expected our builders to construct our homes in a manner that took this concept into consideration. However, we now know the majority of our homes are excessively leaky and inefficient. With this new emphasis on air sealing homes for better efficiency, more emphasis is being placed on the indoor air quality.

The EPA and ASHRAE (American Society of Heating and Cooling Engineers) have been placing an emphasis on commercial building IAQ for quite some time but now say it is very important to pay attention to air quality and ventilation in residential structures. IAQ can be affected by a number of pollutants that are derived from building materials, household products, cleaning and remodeling products, faulty gas appliances, pesticides and a host of other pollutants. ASHRAE standard 62.2 says pollutants should be exhausted out of the home and replaced with fresh air at the exchange rate of .35 of the volume of air in the building every hour. If we ventilate more than this, it is excessive air leakage and less than this is unhealthy. Failure to provide adequate fresh air in our living environment can result in a variety of symptoms and illnesses that may occur immediately or over the long term with permanent damage to our health.

When air sealing your home, if the insulator uses a blower door as they seal, they will be able to keep you within the limits of an air tight home. In addition to this, if you have had an energy audit, the auditor should provide a return visit to your home to re-test ventilation on the backside of repairs and verify safe ventilation standards. There are many “free” unscrupulous services which have surfaced during this time of greening our planet. You know the old sayings “you get what you pay for” and “free is never really free”. An auditor should not only be BPI certified but experienced and unbiased toward any particular product. The Missouri Botanical Gardens oversees the Home Performance with Energy Star program to protect the consumer and sponsors auditors that are providing services that meet Building Performance Institute standards. Additional information regarding auditing standards and Home Performance with Energy Star can be found on their website.



## HEALTH CARE COMMITTEE

The League of Women Voters is in support of the Affordable Health Care Act and opposes its repeal. Our committee has been committed to staying abreast of the happenings since its conception and the struggles faced until final passage.

While a slight majority of the public disapproves of the law, a larger percent disapproves of defunding it. The problem lies in there being a large amount of information circulating and not all of it accurate. Some of the benefits of the law which the public supports are a ban on pre-existing conditions for children, preventive care without co-pay, no lifetime limits on care, assistance to small businesses in the form of tax credits for those who supply health care insurance for their employees and allowing children to stay on their parents' policy until age 26. While all states mandate that drivers must have a license to drive and carry liability insurance and that we must send our children to school, there is objection, in many states, to the U S government having the right to insist that all people have health insurance.

We are now beginning a series of discussions dealing with health care justice. What is the moral imperative of providing health care? Where are the challenges and opportunities? What are the values?

The Health Care Committee will meet at Cape Albeon on Thursday May 12 at 10.30 am  
The topic for discussion will be Justice in Health Care, A Moral and Economic Imperative. Directions: Cape Albeon from Highway 270 and Dougherty Ferry. Go west on Dougherty Ferry to Lake Bend Drive, (after you cross Big Bend) left on Lake Bend Drive and you are there.
