LWV Begins its Second Year of Voters Guide Collaboration with the Post-Dispatch

After successfully producing four Voters' Guides this past year (April, August, November 2010 and March 2011), we are gearing up to produce an April 2011 edition. Featuring more than 950 candidates and 30 ballot initiatives, the Guide will cover St. Louis, St. Charles, Lincoln, Franklin, Warren and Jefferson counties and the City of St. Louis for the April 5th election.

The League's work on the Guides has received rave reviews from the public and the Post-Dispatch staff. It has brought increased visibility to our organization, resulting in invitations to facilitate high profile candidate and issue forums, guest opinion columns and other collaborative efforts. In addition to producing the content for the Guides, League volunteers distributed 30,000 copies to local libraries, senior centers, public recreation facilities, churches, YMCAs and Starbucks.

We need all hands on deck beginning March 2nd to research ballot issues, enter candidate information, process candidate photographs and edit and proofread. Please call the office, 314 961-6869 and volunteer to help with this important work.

FROM the President...

February and March are the anniversary and birthday for the League. It was here in St Louis the end of March 1919 when the suffragists were meeting in their Jubilee Convention on the top floor of the Renaissance hotel at Washington and 8th. It was here that the League was born when [Carrie Chapman Catt](#) said, let there be raised up a league of women voters to finish the fight and be a memorial to the many women who had worked to gain the right to vote, and they realized it was about to happen but they knew the work was not done.

That same week Missouri delegates went to Jefferson City where the legislature was considering a resolution for women's right to vote. It passed and the Missouri delegates reported to the Convention. In celebration they recessed from the Convention to hold a parade.

Many members working to produce a April election voters guide (see p.1). We will be holding more than 10 candidate forums. The public always learns a lot by seeing and talking to candidates in person.

Lastly the League has a Voters Hotline to answer voters' questions about where do I vote, who is on the ballot, what does a yes or no vote mean on a ballot issue and many other questions.

You can see that the League continues the work of the suffragists (began almost 170 years ago) who believed in the right to vote and who began the work to inform and educate the community to participate in our government.

LWVSTL Voter Registration

In 2010 LWVIS was present at 39 Naturalization Ceremonies to register 1,331 new American citizens to vote. Most of the ceremonies were held at the Thomas Eagleton Courthouse; special naturalization ceremonies were held at the Old Courthouse, Parkway South High School, Harris-Stowe State University, and the U. S. Grant Historical Site. The new citizens come from all over Missouri. We sent voter registration forms to 37 Missouri Counties. We register approximately fifty per cent of the new citizens.

LWVIS tries to accommodate all requests for voter registration. The LWV sign was visible at Harrah's Casino, St. Louis Public Schools Open House, YWCA/LWV 90th celebration of the 19th amendment, Festival of Nations, Mehlville School District, Kirkwood School District, Nerinx Hall, and Operation Youth Build. The latter was a class in learning the importance of voting and registering the students to vote. We often don't register many individuals at these sites, but we provide lots of information.

Voters will select party nominees for president of the board of alderman and for Aldermen in even-numbered wards.

Voters vote only one party ballot:

Democratic(D), Green(G), Republican(R).

Voters will elect these officials on April 5.

Unopposed candidates: (only one candidate from one party on ballot.) Ward - 2, 8, 14, 18, 26, 28 - all Democrats.

President of Board of Aldermen: (1-D, 1-G).
