## **HEALTH CARE RESOLUTION passed by LWVUS – June 14, 2010**

Whereas the League of Women Voters of the United States believes quality health care at an affordable cost should be available to all U.S. residents; and

Whereas the current and proposed systems do not achieve the League goals of affordability and access to everyone; and

Whereas an improved Medicare for all, a publicly funded and privately delivered national health care plan is consistent with this goal;

Therefore, be it resolved, we, the representatives of local and state Leagues assembled at the 2010 LWVUS Convention, call upon the LWVUS Board to advocate strongly for bills that legislate for improved Medicare for all.

# **ENVIRONMENTAL QUALITY -- A RESPONSIBILITY FOR EVERYONE!!**

The EQ Committee is focusing on the steps each of us can take in our lives and in our homes to protect our environment. The committee's goals this year are to provide current and accurate information, offer ideas and measures you can adopt in your home, and provide informed answers to questions regarding energy saving measures. This issue we open with the following Energy Conservation low cost ideas and suggestions that will have an immediate and truly beneficial impact on our environment:

**Electricity facts to consider:** one pound of coal is burned to produce a one kilowatt hour of energy. Burning a 100 watt lamp for one hour uses 1 kilowatt of electricity. Up to seventy five percent of that energy is wasted in production and delivery to your home. The average home can use 20-60 pounds of coal a day. The average household creates more carbon pollution than the average car. Given these facts, one can see how reducing your lighting energy usage will have an exponential positive effect on our environment. \*Embrace the use of compact fluorescent lamps (those curly cue Light bulbs) and LED lamps in your home. CFL's use 75% less energy than traditional lamps (remember to recycle/dispose properly) and LED's use 75% less than CFL's.

- \* Install room occupancy sensors which turn off lights when people leave the room.
- \*Many of our appliances and electronics such as cell phones, battery chargers, computers, stereo systems, game consoles, televisions, microwaves and other kitchen appliances keep using electricity even when we aren't using them. Make an assessment in your home and routinely unplug, power down these items or install smart strips to end wasteful ghost loads. Smart strips automatically power appliances off and on when they sense a decrease/increase in the electrical load.

## IMPORTANT ANNOUNCEMENT

Three tiers of new energy efficiency incentives are being offered by the state of Missouri beginning October 4th. The state will pay for an energy audit of your home up to \$500 plus 50% - 70% of subsequent repair costs up to \$19,000 depending on the tiers of repairs chosen. The state is making an allowance for a whole house performance energy audit because this important assessment will enable you to make informed decisions about the most cost effective, energy efficient approach in your home. # HEALTH CARE – INTERNATIONAL RELATIONS PRESENTATION

Two of the League's committees, Health Care and International Relations, are working together to bring members a presentation on obstetric fistula. We encourage all members to join us on **Saturday morning, October 9**, **at 10 a.m.** to hear Dr. Lewis Wall, a renowned authority on the subject. Dr. Wall, an ob-gyn at Washington University, is building a hospital in Danja, Niger. In addition to repairing fistulas, the hospital will also organize outreach efforts to promote maternal health and reduce deaths in childbirth.



Fistula has been labeled the forgotten international women's health and human rights problem. To quote Nicholas Kristof in an op-ed in the *NY Times*: "This is a childbirth injury, often suffered by a teenager in Africa or Asia whose pelvis is not fully grown. She suffers obstructed labor, has no access to a C-section, and endures internal injuries that leave her incontinent.... She stinks. She becomes a pariah."

The meeting will be held on the third floor of Cape Albeon, located at 3390 Lake Bend Drive, Valley Park, at 10 a.m. on October 9<sup>th</sup>. (Take Big Bend west to Dougherty Ferry, turn left, or take 270 to the Dougherty Ferry exit, follow Dougherty Ferry west past Big Bend and then left on Lake Bend.)

## **EXECUTIVE DIRECTOR REFLECTIONS – Anna Mennerick**

Because there are so many busy Leaguers reporting on news, plans, events and issues this contribution will be more of a thought than a full reflection. As you work on both new and old projects, consider inviting someone to help and learn even if you don't need the help. As you bring others in, you are building the future of leadership for your project, the League or the entire community. In addition, there is much to be gained in the short term by having more hands on deck. Sharing the load now can help you feel less burdened and prepare the way for others to step in when you move on to other interests.

# Things you should know about Prop A

(from a March, 2010 presentation to the St. Louis City Ways & Means Committee, shared by Sydell Shayer)

Proposition A is the ballot issue which will ask voters to consider dropping the earnings tax. The **Goal** of the St. Louis Revenue Structure is to maintain a diverse base that grows with the economy at a rate sufficient to maintain City Service.

The **City Earnings Tax** was imposed in 1959. It is an **Individual tax** of 1% of earnings of residents and non-resident of the City for work done for services performed in the City. This tax makes up 85% of the total earnings tax receipts. The rest is a **Corporate Tax** of 1% of net business profits from City businesses or business conducted in the City. The City Earnings tax growth rate for the last 10 year period is less than the property tax but more than sales taxes. It is the largest source of general revenue (\$138.4M in FY09) for City services. It is approximately equivalent to the total general fund costs of the Police Dept. To put it another way, it is equivalent to the costs of the fire department, corrections, refuse department, forestry div. trimming/weed & debris, park maintenance, building code enforcement and street and alley lighting.

If the earning tax was eliminated, the property tax and the sales tax are two possible replacements. The present city property tax rate is \$6.6465 per \$100 Assessed Valuation. An additional \$3.143 would be necessary to compensate for the lost earnings tax. This would increase the property tax more than is statutory allowable.

The current city sales tax rate including all the taxing entities is 8.241%. It would need to be increased by 4.121% or total 12.362% to replace the lost earnings tax. This would be the highest sales tax rate of all St. Louis area municipalities.

The proponents of Proposition A have offered no alternative. The opponents of Prop A see no good alternative to the earnings tax at the present time. The League opposes Prop. A.
